





Figure 3: Human Development Index Indicators









Figure 2: Population Pyramid Eswatini 2017




ECONOMY AT A GLANCE

- Services and Government services accounts for 50% of GDP




Figure 4: Economic Structural Shifts (2000 - 2017)


- Corporate tax reduction at the maximum rate of 10% for ten eyars, applicable only in Manufacturing, Tourism and International Services after due evaluation for qualification.
- Repatriation of Profits: LIberalized foreign exchange mechanism also allows full repatriation of profits and dividends of enterprise operation in the country, Repatriation is also allowed for salaries of expatriate and capital payment.

Legal Protection of Investments: Investments in Eswatini are protected from undue expropriation under the Eswatini Investment Promotion Act of 1998. In addition, Eswatini is a member of Multilateral Investment Guarantee Agency (MIGA) of the World Bank which provides for added legal protection of investments.

 5 Years of work permits are available for expatriate Directors.



- 4 climatic regions: Highveld, Middleveld, Lowfeld and Lubombo plateau.
- Seasons are reverse of Northern Hemisphere
- Winter is dry season, while Summer is raining season.
- Lowveld the less rain (500mm 900mm) per annum.
- Variations in temperature are related to difference in altitude.


Annual rainfall highest in Highveld in the west (1,000mm - 2,000mm), the further east at the



AGRICUTURE

- 2 Types of land use, Title Deed Land (TDL) and Swazi Nation Land (SNL).
- Subsistence farming are characterized by low investment and low yield, mostly SNL
- In contrast, commercial farms such as sugar, corn, citrus fruits and other high value cash crops that are characterized by high levels fo investment in irrigation and productivity and are mostly TDL.
- There are a small number of packaging plants in exporting Eswatini fresh legumes and vegetables to Europe and U.S. (Sidemane farm)
- Currently there are number of local food processing companies that are exporting to Europe, United
 States and Asian countries, include Taiwan!
- These processed foods are: chili sauce, fruit jams, honey, and citrus fruits.

FOOD PROCESSING SIDEMANE FARM

- Small washing and packaging plant specialise in processing baby vegetables and chillies for export to Europe and South Africa.
- Manages neighboring small to medium subsistence farmers in providing products for processing.
- Potential for expansion and add value.

AGRICULTURE: BUSINESS COMES BEFORE INVESTMENT

- Identify and source Eswatini agricultural products as in fresh or in processed form for export.
- Building of national brand identity for marketing.
- Competitive advantages of local produced products:
- There are a number of certified Organic and Fair-Trade farms in the Kingdom.
- Low carbon foot print certification
- Eco and Community friendly certification
- Plenty of space in product development, repackaging for retail market in Taiwan.
- Rich biodiversity of indigenous plants to be discovered for pharmaceutical and food elements, such as essential oils and perfumery plants.

AGRICULTURE: INTENSIVE INVESTMENT OPPORTUNITIES

- 4 climatic zones means throughout the year, a single cash crop or agricultural product can be harvested throughout all 4 climatic regions of the Kingdom.
- Duty Free and preferential market access to the United States and Europe.
- North South Hemispherical difference means Eswatini can provide Winter vegetables to supply Summer market in Northern Hemisphere.
- Regional market demand is increasing, especially on speciality high value vegetables and fruits.
- Diversification of agricultural products is key in dominating regional food market!
- Water retention level and high levels of precipitation in the West versus dry and high temperature in the East means more spectrum of products can be introduced in the region.



CATTLE AND LIVESTOCK INDUSTRIES

- Value and cold chain are limited
- Currently only one company exports Beef to EU, and still under quota!
- Second Abattoir are still in progress of Taiwan FDA certification.
- Eswatini beef in EU are high in demand, price is higher than Taiwan!
- Free-Range happy cows provide succulent tasty meat!



CATTLE RANCH & OTHER LIVESTOCK INVESTMENT OPPORTUNITIES

- Investment in abattoir and cold chain solutions.
- Regional demand for meat is on the increase.
- Poultry farms are currently exporting their products to neighboring countries.
- Taiwan ICDF implemented a successful Pig Industry Enhancement Project



CATTLE RANCH & OTHER LIVESTOCK INVESTMENT OPPORTUNITIES (CONTINUE)

- Investors can consider the larger EU market by setting up cold chain in Eswatini, and export directly to EU region.
- Beef value chain is still incomplete in the Kingdom, thus value adding, processing, packaging and abattoir waste management is still largely unexplored areas of business interest.
